Data protection information for registration at the SFB 1372 Young Researchers Symposium on "Magnetoreception and Navigation in Animals" according to Art. 13 GDPR

We take the protection of your personal data very seriously and handle your personal data confidentially and in accordance with the legal data protection regulations, especially the General Data Protection Regulation (GDPR). In this privacy policy, we inform you about which data we collect during your registration for the SFB 1372 symposium, how it is processed, and what rights you have regarding your data.

Please read the following information carefully.

I. Contact details of the controller and the data protection officer

The Carl von Ossietzky University Oldenburg, a public corporation, legally represented by the President, Ammerländer Heerstraße 114 - 118, 26129 Oldenburg, is responsible for data protection. II. Data collected

In the context of your registration for the symposium, we collect and process the following personal data:

- First and last name
- E-mail address
- Name, Street, City, Zip code and country of your institution

This data is used exclusively for organizing the symposium and for communication with participants. The processing of your data is based on your consent, in accordance with Art. 6 (1) (a) GDPR.

Your personal data will be processed on secure servers of the Carl von Ossietzky University.

In addition, we intend to take photos and videos.

III. Purposes and legal bases of data processing

The personal data you provide as part of your registration will be processed by Carl von Ossietzky University based on Art. 6 Para. 1 lit. e) and Art. 88 GDPR in conjunction with § 88 NBG as well as § 12 NDSG exclusively for the purpose of carrying out the application procedure.

We process your personal data for the following purposes:

- Registration and management of your participation in the symposium
- Communication with you regarding the symposium (e.g., registration confirmation, event updates, programme changes)
- Creation of participant lists and name badges
- Post-event follow-up, such as sending feedback surveys or further information
- The image material will be posted on our homepage and on our social media channels (Instagram, Bluesky).

IV. Recipients of the personal data

Personal data will be made available to the members of the selection committee for the purpose of the administrative implementation of the application process.

V. Data sharing

Your personal data (except for the image material) will not be passed on to third parties.

VI. Duration of the retention or storage of personal data

Your personal data will only be stored for as long as necessary for the above-mentioned purposes. After the symposium and follow-up activities are completed, and latest 180 days after the end of the symposium, your data will be deleted.

Excluded from this is the created and posted image material. We will actively use this for public relations work for up to five years.

We expressly point out the risk of publishing personal data on the Internet. The persons involved in the processing in the executing body have no influence on how unknown third parties use and possibly further process the image when it is published on the Internet.

VII. Your rights

As a data subject within the meaning of the GDPR, you have the following rights:

- Right to information (Art. 15 GDPR)
- Right to rectification (Art. 16 GDPR)
- Right to erasure (Art. 17 GDPR)
- Right to restriction of processing (Art. 18 GDPR)
- Right to data portability (Art. 20 GDPR)
- Right to object (Art. 21 GDPR)

VIII. Right to complain to a supervisory authority

If you believe that the processing of your personal data violates data protection regulations, please contact the university's data protection officer (see above). Independently of this, you have the right to lodge a complaint with a supervisory authority.
