Appendix with guidance for personal comments on the nomination

Criteria and considerations for the selection process

Individual support and communication

- Regular meetings to discuss the doctoral thesis
- Assistance in planning the research agenda
- Availability and time when advice is needed
- Interest in the status and progress of the doctoral thesis
- Creation of a positive working atmosphere in their working group
- Guidance in the writing process

Research environment and research practice

- Detailed guidance on good practice and integrity in scholarly research
- Encouragement to learn new methodological approaches
- Assistance in applications (for research funds or positions)
- Access to necessary equipment and infrastructure
- Offering regular seminars and colloquia for early-career researchers
- Communication of the importance and possibilities of research data management

Integration into the scholarly community

- Encouragement and support for active participation in conferences
- Encouragement and support for publishing your own research
- Support for cooperation at the national and international level
- Help in networking with researchers in your field and expanding your professional network

Professional development

- Discussion of career prospects in academia and research
- Support in considering professional opportunities outside academia
- Encouragement to take part in the Graduate Academy and/or the graduate schools and encouragement to the further development of interdisciplinary skills

Diversity

- Sensitivity to diversity and the personal situation of their doctoral candidates
- Supportive attitude toward international PhD candidates
- Supports the reconciliation of (family) care responsibilities and academic work
