Conditions of use

1. General rules

1.1 The current version of the terms of use holds fort he using of the „Fitness- und Gesundheitszentrum“. The currently applicable version of the terms of use has been delivered to the member of the gym with the conclusion of the contract. The member has to follow the personnel’s instructions. Offences may lead to a house ban.

1.2 The membership cannot be transferred to another person. The member has to inform the staff about modifications of the living conditions, personal data etc. immediately.

1.3 The member gets a user-card for the term of the membership. This card remains property of the University and has to be returned after the expiration of the contract.

1.4 The University assumes no liability for loss or damage of brought materials like clothes, articles or value of money.

2. Suspension/Interruption of the membership

2.1 The membership can be intermitted for a compelling reason for at least one month or at most 6 months. For this time, the mutual rights and obligations are not applicable. Compelling reasons are for example pregnancy, disease or a stay abroad lasting several weeks conditioned by the study. The presence of a compelling reason has to be proved either by a doctor or the authorities. Semester break is not regarded as a compelling reason.

2.2 In the case of a suspension/an interruption, the term of suspension/interruption will be added to the contract duration.

3. Arrear with payments

If the user does not pay the contribution and does not react to a request of payment, the “Fitness- und Gesundheitszentrum” is authorized to ban the member from using the gym or even to cancel the contract extraordinarily.

4. Termination for cause

4.1 The member can cancel the contract extraordinarily without observing a period of notice

- if the member is longer-term ill or injured within the term of the contract and the member cannot or only insignificantly claim the services provided by the „Fitness- und Gesundheitszentrum“ within the remaining term of the contract and a medical certificate is presented

- in case of a move away from Oldenburg if a registration certificate of the new place of residence is presented.

4.2 The University may cancel the contract extraordinarily if the member, despite written request, repeatedly breaches contractual obligations, especially the behavioral code of the conditions of use.

5. Hints/declaration concerning data protection

The member agrees to the fact that a photo has to be made for the access control. The photo and the personal data that are written down overleaf will be deleted one year after the ending of the contractual relationship.
